RESOLUTION : -

With the Agenda of discussion (Agenda-I) it has been a long pending issue for the bifurcation of the erstwhile Nabarangpur - Women's College with two respective entity in terms of land and infrastructure with reference to the Govt. letter vide letter No: 1473 on-dated: 17/01/2022 by the Govt. of Odisha, it was resolved by the President, GB to bifurcate the land in due process and demarcate it in the names of two Colleges with two RER's, so that the developmental work under the OHEPEE and Govt. assisted funds can be properly utilized for greater interest of the College.

It was resolved by the members of the GB of the College with due consent of the President that this matter has already been solved in the DCDFC meeting headed by the Collector and District Magistrate, Nabarangpur along with Additional District Magistrate-cum-President, Governing Body, Nabarangpur Women's Degree College, Nabarangpur, Sub-Collector, Nabarangpur, Tahasildar, Nabarangpur, Regional Director, RDE, Bypore, District Education Officer,

Nabarangpur, Principal of Nabarangpur Women's Degree College and the Principal of Nabarangpur Women's Higher Secondary School, Nabarangpur.

Under Agenda-II the Principal in-charge of the College apprised the members of the Governing Body that Rs. 30 lakhs have been released in three phase manner for the infrastructure development of the College. The said fund shall be Utilized adhering to the guidelines framed by the Govt. either renovation and Construction of boundary wall or Construction of administrative building as pleased by the members of GB of the College. Hence it is resolved by the members of the GB with due Consent of the President to Construct the boundary wall of the College.

In Connection with the above cited Agenda of discussion (Agenda-III) the Principal-in-charge of the College apprised the members that the department of Odia is run by her - Single handedly along with her pressing official work as Principal of the College. Hence it has been immanent that the Second Post of Lecturer-in-Odia shall be appointed by the management of the College, adhering to the Govt. restriction on appointment of Lecturers by the Management of the College. Like Previous appointment Procedure this appointment will be purely temporary as of other management - employees of the College. As such he/she will be appointed with a specific remuneration - Confined to 44 days appointment with a One day break to the Service. On this issue the -

members nodded their due approval discussion - on its different norms of appointment qualification preference. The Principal i/c is directed to go for publication of advertisement, fixing of dates of interview and formation of board of members for the selection process. Hence it was Unanimously resolved for execution of the above cited agenda of matters.

Finally the meeting ended with the vote of thanks by the Principal-in-charge-cum-Secretary to the President, GB and members present in the meeting.
